## ACCEPTABLE USE POLICY

This Acceptable Use Policy (“**Acceptable Use Policy**”) defines Nandalala Infotech’s (“**invoicefree.in**”) policy and procedures concerning the acceptable usage and restrictions on usage of invoicefree.in Products, existing now or in the future. ### 2. Limitations on Content

You agree not to host, upload, publish, transmit, update, share, sell, or purchase any Content, items, or activities through invoicefree.in products which include, but are not limited to, the following:

22. Pyrotechnic devices and hazardous materials, which include fireworks and related goods; toxic, flammable, and radioactive materials and substances;
23. Regulated goods which includes air bags, batteries containing mercury, Freon or similar substances/refrigerants, chemical/industrial solvents, government

uniforms, car titles, license plates, police badges and law enforcement equipment, lock-picking devices, pesticides, postage meters, recalled items, slot machines, surveillance equipment, goods regulated by government or other agency specifications;
