

INVOICEFREE.IN REFERRAL POLICY

This Referral Policy applies to referrals made by existing Users of invoicefree.in Products to invite new users to register and purchase a subscription of invoicefree.in Products. This Referral Policy is part of and incorporated within, and is to be read along with, the Terms of Service <u>https://invoicefree.in/Terms.html</u>. The terms capitalised in this policy and not defined herein shall have the meaning assigned to them in the Terms of Service.

- invoicefree.in rewards existing Users of invoicefree.in Products that encourage new users to register and purchase a subscription of invoicefree.in Products. If a new user (the "Referee") registers and purchases a subscription plan on either of the invoicefree.in Products using a referral code/referral link of an existing User (the "Referrer"), the Referrer and the Referee shall both be entitled to a reward ("Referral Bonus") as detailed in this Referral Policy. The decision as to whether the referral code/referral link is valid shall be made by invoicefree.in at its discretion. invoicefree.in' decision in this regard shall be final and binding.
- 2. invoicefree.in' <u>Cancellation and Refund</u> Policy shall not apply and be available to the Referees who purchase a subscription of invoicefree.in Products using a referral code/referral link. To clarify, no refund shall be provided by invoicefree.in for cancellation of a paid subscription by a Referee.
- 3. Upon successful completion of registration and purchase of a subscription by a Referee using a valid referral code/referral link, the following shall be provided as Referral Bonus:
 - The Referrer shall be eligible for a cash reward of up to INR 500/-. The quantum of the cash reward shall be determined by invoicefree.in its sole discretion, subject to a maximum of INR 500/- ("Maximum Cash Reward").
 - The Referee shall be eligible to receive a discount of 15% on the subscription amount of the invoicefree.in plan they subscribe to.
- 4. In the event that invoicefree in determines (at its sole discretion) that the Referrer is eligible for the Maximum Cash Reward, the Referrer can refer a maximum of five (5) new Referees.
- 5. Notwithstanding anything to the contrary in this policy or elsewhere, the aforementioned Referral Bonus does not apply to the subscription/purchase of invoicefree.in's "Silver" plan. To clarify, if the Referee purchases the "Silver" plan, neither the Referrer nor the Referee will be eligible for any Referral Bonus.
- 6. invoicefree.in shall not provide any Referral Bonus if either the Referee or the Referrer violates this policy or the Terms of Service.
- 7. invoicefree.in has arrangements with banks, affiliates, payment gateways, payment aggregators, and other financial service providers for processing Referral Bonuses ("Service Providers"). invoicefree.in endeavours to ensure that eligible cash

bonuses are processed within 20 working days of the successful purchase of a subscription by the Referee. However, this timeline is indicative, and processing of cash bonuses is subject to the time taken by the Service Providers.

- 8. The Referee and the Referrer agree to provide any information required to facilitate payment of applicable cash bonuses, including but not limited to bank account details, bank branch names, UPI addresses, and IFSC codes. invoicefree.in will facilitate payment of applicable cash bonuses to the bank account or the UPI address provided by the Referrer/Referee. invoicefree.in will not be responsible for non-transfer or non-payment of referral incentive, including applicable cash bonus if incorrect or incomplete information is provided by the Referrer/Referee.
- 9. invoicefree.in reserves the right to discontinue or amend the Referral Bonus and this Referral Policy altogether at any point in time.
- 10. Referral agents/distributors of invoicefree.in, invoicefree.in' partners, invoicefree.in' Employees shall not be eligible for Referral Bonuses under this Referral Policy.
